An agreement establishing the Strategic Alliance (SA) was signed on December 2015

 General objective: Promoting research projects and other activities that address common challenges in agri-food productivity, competitiveness and sustainability, with the purpose of strengthening their capacities in agricultural sciences and innovation.



SP OBJECTIVES:

- Promoting an active exchange of data, personnel and research between the partners
- Collaborating in the process of institutional evaluation of the members of the SP, and sharing best practices on research management (institutional development), technology transfer and innovation
- Promoting human capital strategic development, postgraduate fellowships (sabbatical periods)
- Promoting scientific activities among members of the SP (Including Joint Research Programmes and joint applications for research grants)



GOVERNANCE MECHANISM

- Board of Directors: With representatives of all partners
- Scientific and Technical Committee for identification of inter-institutional projects of the best scientifictechnical quality and most strategically relevant
- Executive Secretary: Open call, appointed by the Board of Directors
